__19. One proposal would establish a Constitutional Amendment to protect the individual right to reproductive freedom, including the right to make and carry out all decisions about pregnancy, such as prenatal care, childbirth, postpartum care, contraception, sterilization, abortion, miscarriage management, and infertility; allow the state to prohibit abortion after fetal viability unless needed to protect a patient’s life or physical or mental health; forbid state discrimination in enforcement of this right; prohibit the prosecution of an individual, or a person helping a pregnant individual, for exercising the rights established by this amendment; and invalidate all state laws that conflict with this amendment. Would you vote yes or no on this proposal?

__21. Another proposal, called Promote the Vote, would establish a Constitutional Amendment that would recognize the fundamental right to vote without any harassing conduct; require military or overseas ballots to be counted if postmarked by election day; provide voter right to verify identity with a photo ID or signed statement; provide voter right to a single application to vote absentee in all elections; require state-funded postage for absentee applications and ballots; require state-funded absentee-ballot drop boxes; provide that only election officials may conduct post-election audits; require 9 days of early in-person voting; allow donations to fund elections, which must be disclosed; and require canvass boards to certify elections based only on the official records of votes cast. Would you vote yes or no on this proposal?

__22. Another proposal, called Term Limit Reform, would establish a Constitutional Amendment that would require candidates for state office to file financial disclosure forms detailing sources of income, holdings, liabilities, agreements for future employment, gifts, and other information. The proposal would also amend the state’s term limit law to cap at 12 years the combined total number of years a person could serve in the State House and/or State Senate. Current term limits restrict House members to 6 years and Senate members to 8 years. Would you vote yes or no on this proposal?
