INTRO TO Q. 11: Now I would like to read a more detailed statement about Proposal 1. Increasing the state sales tax from 6 to 7 cents would raise about 1.6 billion dollars per year, with 1.3 billion dollars going to state road, street and bridge improvements; 300 million dollars per year in new increased funding going to local public schools, equal to about $\$ 200$ per pupil; 112 million dollars going to mass transit services; and 95 million dollars in increased revenue sharing going to local governments. The sales tax increase would in part replace 752 million dollars in revenue that currently goes to schools and local governments has been generated by the existing 6 percent sales tax charged on gasoline at the pump, which would be eliminated. Also, the existing gas tax and diesel fuel tax would be replaced with a tax charged at the wholesale level, resulting in an estimated 3 cent per gallon gas tax increase above 2013 levels. Vehicle registration fees would increase by eliminating a 10 percent per year discount new car buyers receive for the first three years they own their cars, as well as increasing registration fees for hybrid and electric vehicles, which will raise an additional 45 million dollars. It will also increase annual fees for heavy commercial trucks by 50 million dollars. The Earned Income Tax Credit, which was reduced in 2011, would be fully restored, which will provide about $\$ 300$ per year in tax relief for lowincome families. Universities would no longer be funded from the state School Aid Fund, meaning funding from that source could only be used for local public schools and community colleges.
