As I just mentioned, if the personal property tax on businesses is repealed, it would eliminate about \$770 million in revenue that currently goes to cities, villages and townships, and about \$500 million that currently funds local public school districts. Elimination of this local revenue source will likely result in major cuts in police and fire protection, as well as other local government services such as street repair and snow removal. It would also require many local public school districts to lay off teachers and support staff and cut existing programs to balance their budgets.
